Drop-out prevention: Develop partnerships, public and private, on elementary, middle, and secondary campuses to aid at-risk students with such critical issues as school attendance, literacy, job preparedness, teen pregnancy, drug and alcohol abuse, teen suicide and school violence. The organization provided comprehensive case management services to 2,572 at-risk students during the year ended August 31, 2016. These students received over 28,000 hours of services targeted to each student's area of need (such as behavior, academics, attendance, etc). As a result of these services 99% of the case managed students remained in school with 96% being promoted to the next grade.
